2023 TBPA Board Member Professional Certification Scholarship Application

The Tampa Bay Paralegal Association ("TBPA") is pleased to award one (1) Professional "Certification Scholarship" to a Board Member to cover the cost of the PACE, PCCE, OR CP Review Manual and the exam fee (not to exceed \$350.00), to assist with the expenses associated with preparing for and taking the Paralegal Advanced Competency Exam ("PACE") or Paralegal Core Competency Exam ("PCCE") as administered by the National Federation of Paralegal Associations, Inc. ("NFPA") to achieve the professional designation of Registered Paralegal ("RP") or Certified Paralegal Exam administered by the National Association of Legal Assistants ("NALA"). The scholarship will be presented to the recipient at the TBPA Annual Seminar held in Tampa, Florida on April 21, 2023.

Please read this application carefully and follow all instructions. Applications must be received by February 28, 2023, to be considered for the award.

Eligibility: TBPA "active" member in good standing who meets the following criteria: (1) employed or retained as a paralegal as currently defined and adopted by the Florida Supreme Court and the Florida Bar; (2) resides or works in either Hillsborough, Manatee, Pasco, Pinellas or Polk Counties; (3) meets the National Federation of Paralegal Associations' ("NFPA") eligibility criteria to take PACE/PCCE OR meets the NALA eligibility criteria to take the CP Exam. For more information regarding NFPA's requirements to sit for the PACE/PCCE exam, see NFPA's web site at www.paralegals.org. For more information regarding NALA's requirements to sit for the CP exam, visit NALA's website at www.nala.org. Recipients must renew their TBPA membership for one year following award of the scholarship and must write an article for TBPA's newsletter/website describing their experience studying for and taking the exam OR explain how winning the scholarship and/or achieving certification has impacted their career.

In no event may the candidate be a sustaining, associate or student member of TBPA. This professional scholarship is a one-time award. Past professional scholarship recipients are ineligible to re-apply for future awards after being awarded the scholarship.

Disqualification: An applicant shall be disqualified (i) for being convicted of a felony or comparable crime, as defined by an individual state that does not have felony designations, (ii) if the applicant is currently under the suspension, termination, or revocation of a certificate, registration or license to practice by a professional organization, court, disciplinary board or agency in any jurisdiction, or (iii) if the applicant has been found to have engaged in the unauthorized practice of law. All illegible applications, applications received after the deadline, or applications lacking the required information, documentation or attachments, shall also be disqualified.

Selection: Recipients will be eligible for the award on the basis of paralegal work experience, commitment to a career as a paralegal, writing capability, volunteer activity, and references. Award recipients must continue their certification preparation immediately following notification of the award or, if already prepared, then sit for the PACE/PCCE or NALA exam. Applications will not be returned. All decisions are final. Applications will be evaluated according to the following criteria:

40% Paralegal Work Experience/Progression & Paralegal Career Plans

Writing Sample (Essay on why you seek certification as a RP®, CRP® or CP and how it will enhance your career OR if you win the

scholarship how you will promote and support Certification to the members of TBPA.)

20% TBPA Volunteer Activity

10% Letters of Reference

The Education/Professional Development Committee will review all completed applications submitted, select the scholarship applicant meeting the selection eligibility criteria, and present the committee's recommendation of the selected recipient to the Board of Directors at the monthly Board meeting immediately following the **Deadline Date of February 28, 2023**. The approved recipient will be invited to the TBPA Annual Seminar held on April 21, 2023, and will be awarded the scholarship. The scholarship recipient shall notify TBPA as soon as they are prepared to apply and sit for the exam, at that time, TBPA will issue a check to NFPA/NALA for the cost of the application and exam fee. If the scholarship recipient does not sit for the exam by April 30, 2024, the scholarship will be forfeited and TBPA shall redistribute the funds at the Board's discretion and donate the funds to TBPA's current charitable organization. Scholarship Recipient may submit a written request for a one-time 3 month extension to sit for the exam, to be approved at the discretion of the Board of Directors.

Application Deadline Date: Applications must be postmarked on or before February 28, 2023.
