2018 TBPA Professional Certification Scholarship Application

The Tampa Bay Paralegal Association ("TBPA") is pleased to award one (1) **Professional Certification Scholarship** to cover the cost of the National Federation of Paralegal Associations, Inc. ("NFPA") PACE or PCCE PACE/PCCE Review Manual and the Exam Fee OR the NALA CP Review Manual and Exam Fee (not to exceed \$350.00), to assist with the expenses associated with preparing for and taking the Paralegal Advanced Competency Exam ("PACE") or Paralegal Core Competency Exam ("PCCE") as administered by NFPA or the Certified Paralegal ("CP") Exam administered by the National Association of Legal Assistants, Inc. ("NALA") to achieve the professional designation of Registered Paralegal ("RP"), Core Registered Paralegal ("CRP") or Certified Paralegal ("CP"). The scholarship will be presented to the recipient at the TBPA Holiday Luncheon held in Tampa, Florida on December 14, 2018.

Please read this application carefully and follow all instructions. **Applications must be postmarked by October 31, 2018 to be considered for the award.**

Eligibility: TBPA "active" member in good standing who meets the following criteria: (1) employed or retained as a paralegal as currently defined and adopted by the Florida Supreme Court and the Florida Bar; (2) resides or works in either Hillsborough, Manatee, Pasco, Pinellas or Polk Counties; (3) meets the National Federation of Paralegal Associations' ("NFPA") eligibility criteria to take PACE/PCCE OR meets the NALA eligibility criteria to take the CP Exam. For more information regarding NFPA's requirements to sit for the PACE/PCCE exam, see NFPA's web site at www.paralegals.org. For more information regarding NALA's requirements to sit for the CP exam, visit NALA's website at www.nala.org. Recipients must renew their TBPA membership for one year following award of the scholarship and write an article for TBPA's newsletter/website describing their experience studying for and taking the exam OR explain how winning the scholarship and/or achieving certification has impacted their career.

In no event may the candidate be a sustaining, associate or student member of TBPA. This professional scholarship is a one-time award. Past professional scholarship recipients are ineligible to re-apply for future awards after being awarded the scholarship.

Disqualification: An applicant shall be disqualified (i) for being convicted of a felony or comparable crime, as defined by an individual state that does not have felony designations, (ii) if the applicant is currently under the suspension, termination, or revocation of a certificate, registration of a certificate, registration or license to practice by a professional organization, court, disciplinary board or agency in any jurisdiction, or (iii) if the applicant has been found to have engaged in the unauthorized practice of law. All illegible applications, applications received after the deadline, or applications lacking the required information, documentation or attachments, shall also be disqualified.

Selection: Recipients will be eligible for the award on the basis of paralegal work experience, commitment to a career as a paralegal, writing capability, volunteer activity, and references. Award recipients must continue their certification preparation immediately following notification of the award or, if already prepared, then sit for the PACE, PCCE or CP exam. Applications will not be returned. All decisions are final. Applications will be evaluated according to the following criteria:

40%	Paralegal Work Experience/Progression & Paralegal Career Plans
30%	Writing Sample (Essay on why you seek certification as a RP®, CRP® or CP and how it will enhance your career OR if you win the scholarship how you will promote and support Certification to the members of TBPA.)
20%	TBPA Volunteer Activity
10%	Letters of Reference

The Education/Professional Development Committee will review all completed applications submitted, select the scholarship applicant meeting the selection eligibility criteria, and present the committee's recommendation of the selected recipient to the Board of Directors at the monthly Board meeting immediately following the **Deadline Date of October 31, 2018**. The approved recipient will be invited to the TBPA Holiday Luncheon on December 13, 2018, and will be awarded the scholarship/Test Fee Voucher. **The scholarship recipient must sit for the exam within one year (no later than January 31, 2018) of receiving the Scholarship or the scholarship will be forfeited. The scholarship recipient shall notify TBPA and redeem the Test Fee Voucher as soon as they are prepared to apply and sit for the exam (no later than January 31, 2018), at that time TBPA will issue a check to NFPA/NALA for the cost of the exam fee.**
